Andrea in enrolled in the 2014 Registered Nursing Program at FCC

Andrea H. is a domestic-violence survivor and the single mother of four children, one girl age 9 and three boys, ages, 7, 3, and 1 years old. Andrea has been in our Transitional Housing Program for a year, and during this time she has worked full-time as a certified nursing assistant while attending Frederick Community College (FCC) part-time to satisfy prerequisite courses for a Registered Nursing degree. Because of prior school debt, Andrea paid for all of her pre-requisite coursework herself, and Advocates has assisted her by paying for textbooks. An A/B student, Andrea recently was one of 30 applicants accepted into FCC's 2014 Registered Nursing degree program. Due to her diligence and good grades, Andrea is now eligible for scholarship funding. She has reduced her work hours so she can go to school full-time, and her only income sources are her part-time earnings and food stamps.

Andrea is a very determined lady! She is a devoted mother and astute budget manager. We are so very proud of her accomplishments and her willingness to build a better life for herself and her children. Like many of our participants, Andrea has grasped the concept that achieving personal milestones will lead her to financial stability.



Joy is enrolled in FCC's Legal Studies Program

Joy W. is a single mother of four children, two boys ages 17 and 16 and two girls ages 15 and 7. Joy was referred to us by Frederick County Public Schools and had been living in a motel room with funding about to run out just before Christmas 2013. Joy faces a number of barriers to success – an erratic work history with no clear career goals, some college coursework, a failed marriage, and an unmanageable debt load. Now, safely housed in our Transitional Housing Program, Joy has had time to take stock and develop a plan for the future. In the short time she has been with us. Joy has obtained a permanent part-time job with a local department store, enrolled in the food stamp program, and developed a plan for debt reduction. Working with Adult Services at FCC, Joy has enrolled in the school's Paralegal Studies Program and has paid for her first two classes herself. Her three teenagers are all active in the school band and Joy takes the time to ensure their full participation.

We are excited to be able to work with Joy and help her position herself for a brighter future and increased financial stability. She has hit the ground running and we want to help her over the finish line! Like all of our participants who need to re-establish themselves, Joy is beginning to understand and appreciate the adage that "time takes time," and her recovery from near homelessness will require steady measurable progress.

## **Our Eligibility Requirements**

On average, Advocates supports 20 families in our Transitional Housing Program and 12 families in our Families Forward Program. We are very conscious of our mission to assist homeless and families at risk of homelessness achieve an increased degree of self-sufficiency and economic stability.

Our programs are fairly rigorous inasmuch as we require adults to go to school to enhance their future employment options, to work, and to effectively manage a household budget. Those families in our Transitional Housing Program are required to demonstrate responsible tenancy by paying a monthly housing fee, keeping an orderly clean house, and maintaining the yards and walkways. With limited time and resources, we strive to help those families in great need who are also willing and able to help themselves. To be admitted into our programs, applicants must:

- Be a Frederick County resident
- Be homeless, imminently homeless, or living in housing not suitable for human occupancy
- Have an annual income of less than 30% of the average area median income or less than \$26,000
- Be eligible for public housing
- Be able and willing to go to school
- Have custody of one or more minor children
- Be drug- and alcohol free where there has been a history of abuse
- Be 18 years or older
- Have proof of all income
- Not be on methadone
- Not be chronically homeless

Our operating philosophy is to provide a hand-up and not a hand-out. Parents who are not willing to go school and/or work to overcome their homeless status cannot stay in our programs.

## **Board Members Sought**

Advocates is seeking new members for the Board of Directors, the governing body of Advocates for Homeless Families. Board members typically meet once every month in the evening for one and one-half hour formal meetings, and each board member serves on a committee that meets monthly for one to two hours. The Board committees are the Development Committee, Finance Committee, Strategic Planning Committee, and the Program Committee. Serving on our Board of Directors is a great way to influence the future of Advocates and enhance our programs to help homeless families achieve independence. # Collaborations at Work!

Advocates' Executive Director Ken Allread and one of our graduates has been asked to serve on the Frederick Rescue Mission's program committee to assist in the development of the programs for the Rescue Mission's Women's and Children's Shelter, planned to open in December 2014.

Working together we hope to create programs for women that will help them start their journey to overcome homelessness sooner rather than later. We envision a coordinated approach to address each adult participant's requirements to achieve financial and housing stability through job training and employment, education, life skills training, and case management services. The Rescue Mission's Executive Director Arnold Farlow and Ken Allread both believe that women can begin their recovery from homelessness while in shelter and then transition into Advocates transitional housing program for more intensive focus on job training and education to enhance their future employment options. Those women in shelter who enroll in the Rescue Mission's personal development program will be able to attend Advocates' weekly Life Skills Workshop.
