Overcoming Barriers to Success!

One of the biggest obstacles to self-sufficiency that homeless women with children face is the lack of reliable transportation. Can you imagine trying to care for one, two, three or more children with an income of less than \$1,000 a month while trying to find employment and go to school without a car? Sounds impossible, doesn't it? One of the solutions Advocates provides to the participants in our program is through our active community partnerships with Second Chance Garage and, most recently, with the Students Homeless Initiative Partnership (SHIP).



Emily acquired her car through Second Chances Garage

Emily L is a homeless single mother of three boys (ages 6, 4, and 2 months) enrolled in our Transitional Housing Program. She works part-time in retail while attending Frederick Community College full-time. She is pursuing paralegal studies certification. Her monthly income is \$670.00. Emily is an excellent money manager and accounts for every dime. Even so, without the heavily discounted, previously owned vehicles offered by Second Chance Garage to those in great need, ownership of a car would be beyond Emily's means. To obtain the car, Emily had to demonstrate her ability to manage a household budget, including future payments for car maintenance and insurance, and save for the baseline price of the auto. Congratulations to Emily!

Anita Acquired a Car From Community Support!

Anita B also is a single homeless mother of two children (a girl age 4 and a one-year old boy) and is enrolled in our Transitional Housing Program. Anita is attending classes in Frederick Community College's certified nursing assistant program and is currently seeking employment. Her monthly income is \$600.00 a month.

Three weeks ago Anita was driving back from a job interview when her 1996 Chevy broke down on I-70. After towing the car to Second Chances Garage, the verdict was that the cost of repairs far exceeded the value of the car and Anita's ability to pay for the repairs. We reached out to Ed Hines, chair of Students Homeless Initiative Partnership, to see if the organization could help Anita and her children. Ed posted Anita's situation on Facebook, and within two weeks SHIP supporters had donated \$500 toward the cost of a previously owned auto and a private citizen stepped up and advised that he had a second car he would sell for \$800.00. Advocates is putting up the additional \$300 to cover the total purchase price and Anita will be able to accept the car and title the first week in May 2014.

Anita did get the job that she had interviewed for the day her car broke down. She will be working at an insurance call center while finishing her studies. She now will be able to travel to and from work and school and transport her children to childcare with the comfort that comes with reliable transportation. It is amazing what an informed and caring community can accomplish in a very short period of time!




